**A. Original Transfer Certificate. (In case of Inter-state transfer, the T.C should be duly countersigned by the inspector of schools).**

**B. ADDRESS - PROOF :**

1. Ration card issued in the name of Parents (mother/father having name of the child).
2. Domicile certificate of the child or of his/her parents.
3. Voter I-Card of any of the parents.
4. Unique Identity card of mother/father/child issued by Government of India.
