Subject: Recognition of School from Nursery to VIIIth Std.

Sir/Madam,

With reference to your application on the subject cited above, I am directed to convey the approval of the Director of Education, Delhi for the recognition of the existing Nursery school to VIII th std. without aid w.e.f. 1994-95 session subject to the following terms and conditions.

1. That the school shall abide by the provision of Delhi School Education Act/Rules, 1973 framed there-under as well as the instructions issued from time to time.

2. That the school shall admit students without any discrimination of caste and creed.

3. That the school shall meet the additional liability of Middle classes.

4. That a proper library shall be established and facilities for reading room/a hall also be made available for students as well as teachers. Books as per the ratio of 10 books per students shall be purchased and made available to the students.

5. That adequate sports material shall be purchased and made available to the students.

6. That the school shall strictly abide by the provision of section 10(1) of Delhi School Education Act/Rules, 1973.

7. That the school shall not run any unauthorised classes, any other activities within the school premises and all the raised classes shall be run at one place at the premises of the school immediately, if any.

8. That the school shall dispense with the service of unqualified and over-aged staff, if any immediately.

9. That the service contract between the school management and the employees be revised as Delhi School Education Act/Rules, 1973 shall be executed immediately.

10. The Management Committee of the school shall not increase fee in future academic session without prior approval of Director of Education, Delhi as a mandatory requirement under sub-section (3) of section 17 of Delhi School Education Act and Rules, 1973.

The Management Committee shall regulate the functioning of school strictly in accordance with the provision of DSEA & Rules, 1973.

12. That all the facilities prescribed under rule 59651 of DSEA & Rules, 1973 shall be made available to the students.
13. Proof of the effect that qualified staff has been provided and as per Act & Rules be provided for the verification of E.O./Dy. E.O.
14. That the arrangement for good drinking water shall be made available to all the students as well as the teachers and sanitary facilities shall also be provided to the students adequately.
15. That the school shall comply with the norms of the DSER, 1973 for affiliation for examination purpose.
16. Medical facilities /leave, LTC, Bonus, Teaching allowances, and G.P.F. etc. be paid since recognition of school.
17. Provident Fund register be maintained and cash book be completed and shown to E.O. of the Zone concerned for verification from time to time.
18. That the management of the school shall create a reserve fund
19. That the violation of any institutions/conditions/rules and regulation of the department shall lead to the withdrawal of recognition of the school.
20. That in no case the school funds will be diverted/transferred to any other fund/account of the society. The school funds will also not be utilised by the Society for any other purpose than the school.
21. That report about fulfilment of the above conditions shall be sent to the E.O. every six months.

7. That the school shall not run any unauthorised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the premises of school.
8. That the school shall dispense with the service of unqualified and over-aged staff, if any immediately.
9. That the service contract between the Management and the employees be revised as per DSER and Rules, 1973, shall be executed immediately.
10. The Management Committee shall regulate the functioning of school strictly in accordance with the provisions of DSER, 1973.
11. The Managing Committee of the school shall not increase fees in future academic session without prior approval of Director of Education which is a mandatory requirement under sub section(3) section 17 of Delhi School Education Act & Rules 1973.
12. That all the facilities prescribed under rule 50 & 51 of the DSEA and Rules, 1973 shall be made available to the students.
13. Proof to the effect that qualified staff including the Principal appointed as per Act & Rules be provided for the benefit of the S.C. concerned.

17. Medical facilities/leave, LTC, Bonus, Teaching allowances, Provident fund etc. be paid since recognition of school.
18. Provident fund register be maintained and cash book be completed and shown to E.O. of the Zone concerned for verification from time to time.
19. That the Management of the school shall open a reserve fund in the form of Fixed Deposit in the joint account in the name of Dy. Director of Edn. (South West) and the Manager of the school - equivalent to 3 months salary of the staff.

23. The upgradation to Sr. Sec School level is allowed in Arts and Commerce and Science stream.
